The Mozambique LNG export project, which has been under force majeure due to attacks by Islamic State terrorists, could begin operations by 2026-2027. Singh added.

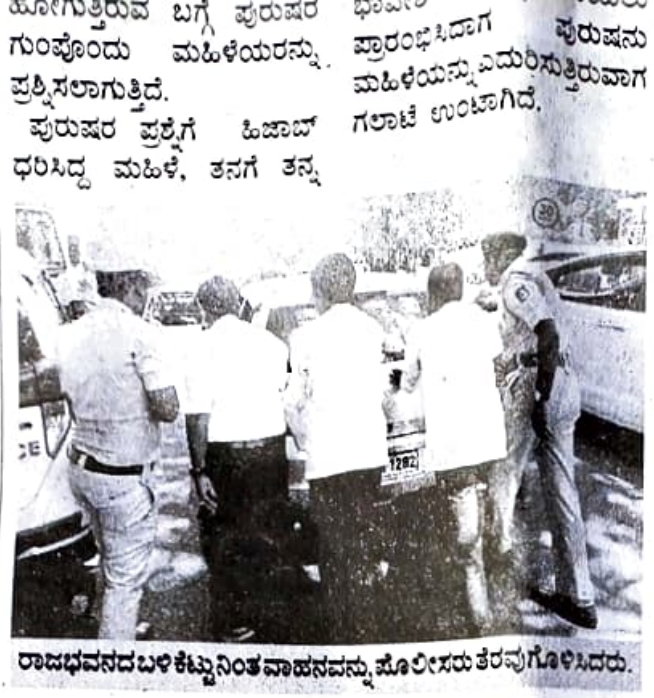
